- Telegraphic /fax/incomplete/after due date request will not be considered for issue of bid documents.
- Bidding documents in proper sealed envelope will be received in the office of Assistant Director works by 02:00 pm up to 7<sup>th</sup> January, 2015 and will be opened by the tender opening committee in the presence of the contesting contractor /their authorized representative on same day at 03:00 PM
